## Biography

Malcolm began his career in zoos over 30 years ago as an animal keeper at London Zoo, before progressing to section manager and curator roles across both ZSL London and Whipsnade Zoos.

He now fulfils a key Zoological Society of London leadership role as an experienced and highly motivated Chief Zoological Officer, with a prominent profile in the global zoological community. As ZSL's most senior zoological expert, he represents ZSL across a number of forums and often takes the lead as their media spokesperson on matters relating to the zoos.

Malcolm is responsible for developing and implementing strategies that ensure ZSL is a globally recognised centre of excellence for species care, science, and conservation impact. His zoo teams are actively working on conservation projects across the UK and around the world, including initiatives in the Philippines, Vietnam, Thailand, Indonesia, Mexico and India.

His role also involves training international ex-situ and in-situ conservation professionals, veterinarians and students through zoos and in range countries. His teams are leading on the delivery of multiple training courses for oversees wildlife ranger service, as well as teaching on courses for veterinary graduates.

Malcolm's professional roles and responsibilities include sitting on the EAZA council, member of the BIAZA Elephant Taskforce and as WAZA Sumatran tiger GSMP Convenor. He has a number of peer-reviewed publications on the care and welfare of animals in zoos and recently participated in a panel discussion on the role of zoos in 2050 at the EAZA Directors conference.

#### **Biography**

I grew up on and later jointly owned small holdings in Warwickshire and Wales. Amongst our various animals, we kept Ostriches, Llamas, three Rheas, several Vietnamese pot-bellied pigs, some black cattle known as Dexters, two ponies, some goats, many geese and chickens, and a large number of sheep. Our animals were always treated more like pets than livestock. There were always jobs to do on the farm and I've done many of the tasks you might

I'm currently an Associate Professor of Finance at Heriot-Watt University. I teach Corporate Governance and Sustainability at Heriot-Watt and have done so for most of the last 27 years. Dee then followed her passion for nature conservation, our natural heritage and landscapes by joining Scotland's largest membership charity, the National Trust for Scotland, as its Director of Policy & Communications. Dee led all policy responses to consultations, including on sustainability, regeneration and biodiversity.

Dee returned to London to spend 9 years as an award-winning Director for the companion animal welfare charity Battersea, where she delivered transformational brand growth, positioning Battersea in the UK's top 10 best known charities; led a campaign that changed legislation on cruelty to dogs and cats; and she secured the ITV Paul O'Grady TV series, which boosted Battersea's supporter base and legacy income.

Dee is a consultant for the Commonwealth War Graves Commission, pitching documentaries on its iconic work to Commissioners at major TV channels.
