# **Prof Mary Bownes**Biography

I studied biology, and my career as a biologist was spent at universities in Sussex, Freiburg, California, and Essex before joining Edinburgh University. I taught and researched developmental biology, genetics, and molecular biology.

I trained PhD students from around the world and collaborated internationally. I was Head of the Institute of Cell and Molecular Biology and became Senior Vice Principal with responsibilities including postgraduates, fundraising, external engagement, and widening access.

I have extensive experience with boards and external bodies, such as Highlands and Enterprise and UK research councils.

In retirement, I volunteer my time to share the experience I gained over my career with charities involved in outreach, education, and conservation.

My husband and I have lived in Edinburgh for many years. My daughter trained as a Glasgow Vet and lives with her family in Yorkshire. We have all travelled extensively. My highlights include the Galapagos, Kruger Park in South Africa, Yosemite, Grand Canyon, Sri Lanka, Madagascar, and Australia. All are now suffering from serious environmental challenges.

I have seen so many positive developments in recent years at RZSS. We contribute to breeding programs and conservation globally. Rewilding projects are successful, and progress toward saving 50 endangered species is remarkable.

Our zoos provide wildlife education, whilst offering a fun day out. The Highland Wildlife Park underwent a dramatic transformation to engage visitors. Ambitious plans exist for Edinburgh Zoo development. I would like to continue to be part of this.

My professional career was largely in the private sector, the majority of which in the consulting and accounting firm KPMG. Latterly during the pandemic, I was an Executive Director at the mental







health charity SAMH. For the last 15 years I have held a number of Non-Executive roles including currently, as Chairman of the House for an Art Lover in Glasgow.

# **Prof Andrew Kitchener** Biography

I have been Principal Curator of Vertebrates at National Museums Scotland (NMS) since 1988 and my involvement with RZSS is almost as long as a member of the Animal Welfare Advisory Group, as it is now, and since 2024 I have chaired the RZSS Conservation Advisory Group. I was a RZSS Board member from 2000 to 2009 and again since 2021.

In my museum role I am responsible for the care and development of the national vertebrate collections, numbering about 500,000 specimens, and I work closely with zoos in the UK to preserve specimens and make them available for research. I collaborate widely in my research, including with the RZSS WildGenes Lab, and have more than 280 peer-reviewed research publications. I have worked on several permanent and temporary exhibitions, including *Monkeys. Our Primate Family*, which returns to NMS in June 2025.

I have a number of national and international advisory roles, including the Scottish Animal Welfare Commission, leading the Cat Classification Task of Force of the IUCN Cat Specialist Group and membership of the IUCN Equid and Canid Specialist Groups. I am also Chair of Trustees of the People's Trust for Endangered Species, which supports conservation in the UK and overseas. I am Chair of the Scottish Wildcat Conservation Action Plan Steering Group and have been involved in the development of a new national strategy as well as being a member of the Saving Wildcats advisory committee. I was appointed Honorary Professor by the University of Edinburgh in 2024.
